**Water Rates**

**Sandy City Residents and County Residents with Granite Water Stock or Bell Canyon Agreement**

Base Rate (monthly charge)	
3/4" meter	\$20.40
1" meter	\$27.63
Overage (above 6,000 gal.)	
Off Season (Nov - May) / 1,000 gal.	\$1.43
Peak Season (June - Oct) / 1,000 gal.	\$2.42

**Assistance Program and Military Leave Rate**

Base Rate - For those meeting eligibility requirements, base rates are 50% for assistance and no base rate for military leave.  
Overage (usage above 6,000 gallons) - Overage rates are 100% for assistance and 50% for military leave.
